

DOCUMENTARY TRANSFER TAXES FOR THE STATE OF CALIFORNIA

Documentary transfer taxes are fees that counties, cities, or both may levy on documents related to real property transactions. These taxes apply when the consideration or value of the property being transferred exceeds \$100, excluding any existing liens or encumbrances at the time of sale. In some cities, an additional local documentary transfer tax is imposed alongside the county tax.

In Los Angeles County, the authorized transfer tax rate is \$1.10 for every \$1,000 of the property's consideration or value, excluding any liens or encumbrances. Keep in mind that the specific documentary transfer tax amount may vary depending on the city. Even if your city is not listed, you will still be subject to the \$1.10 per \$1,000 rate for the Los Angeles County documentary transfer tax.
